Job Summary:

Under general supervision, performs activities associated with scheduling and dispatching 14 CFR Part 121 flights. Monitor other company assets for Everts Air Cargo and Everts Air Fuel. Everts Air Cargo operates in Alaska, the Contiguous United States, Canada, and Central/South America/Caribbean in cargo and passenger operations.

Essential Functions:

Ensure safety of flight while performing the following duties:

- 1. Exercise operational control authority in conjunction with the Pilot in Command (PIC) for the safe and efficient operation of flights in accordance with FAA regulations and company policy.
- 2. Must have a complete understanding of the company procedures, limitations, and directives applicable to the rules of 14 CFR Part 121 and company Operation Specifications.
- 3. Review, analyze and monitor present and forecast weather conditions, including but not limited to NOTAMs, PIREPs, TFRs and runway conditions.
- 4. Produce computerized flight plans using MX Excel and Navtech Flight Planning for all company aircraft (C-46, DC-6, DC-9, MD-82/83, and B-727)
- 5. Communicate using telephone, cell phone, email, company radio networks, ARINC, and other means.
- 6. Monitor the progress of each flight and immediately report any overdue aircraft.
- 7. Provide the PIC with all applicable information for the safe conduct of flight.
- 8. Determine the maintenance status and capability of company aircraft, which includes:
 - a. Weight and Balance procedures as described in that chapter of the Aircraft Operating Manual
 - b. Runway analysis review as contained in that section of the Airport Analysis Manual
 - c. Aircraft performance information as described in that chapter of the Aircraft Operating Manual
- 9. Respond to interruptions in service with recommendations and notifications as appropriate.
- 10. Monitor and ensure flight crewmembers are scheduled in accordance with flight and duty time regulations, including provisions of 14 CFR Part 117 and 121.
- 11. Responsible for crewmember selection, scheduling, and notification.
- 12. Assist with flight crewmember travel and hotel arrangements after normal business hours and in the absence of the Travel Department.
- 13. Responsible for accurate reporting of crewmember flight times to payroll.
- 14. Initiate emergency response procedures as required by the company Emergency Response Plan.
- 15. Provide excellent customer service at all times.
- 16. Manage and coordinate the execution of the daily schedule. Control the process and personnel to manage real-time operational decisions.
- 17. Other duties as assigned.

Additional Responsibilities:

Safety

- 1. Comply with all safety aspects, specific practices and procedures of the work scope and position(s).
- 2. Be familiar with the Company's Safety Management System (SMS) and Occupational Safety Manual (OSM).
- 3. Contribute to the Safety Culture of the Company and report any Safety Hazards.
- 4. Required to learn and understand Dangerous Goods Transportation requirements.
- 5. Keep your work areas clean and free of hazards; correct unsafe conditions when encountered and report those that you are unable to personally correct, to a supervisor.

Security

- 1. Comply with all security practices, policies, and procedures as trained.
- 2. Maintain employee vigilance and report all security concerns.

Administrative

- 1. Build an organizational culture in which passion for continuous improvement is innate.
- 2. Ensure adherence to procedures that promote the health and welfare of all employees.

- 4. Must be proficient in MS Word, Excel, Email, PowerPoint, etc.
- 5. Passionate attention to detail.
- 6. Have strong organizational, analytical, and problem-solving skills. Requires a great deal of coordination among many departments.
- 7. Must be flexible, willing to work various hours including holidays, nights, weekends, and overtime. Everts Air Cargo operates 24/7, 365 days a year.
- 8. Must be able to multitask effectively in a busy, fast-paced environment.
- 9. Must be diplomatic, exhibit objectivity and openness to others' views, gives and welcomes feedback, demonstrates accuracy and thoroughness.
- 10. Function in a high stress environment and work well under pressure.
- 11. Strong math background and perform mathematical computations using decimals and hours and minutes and converting from one to the other.
- 12. Have a good grasp of Alaska geography. Know or be able to learn ICAO airport identifiers.
- 13. Be a self-starter with initiative.
- 14. Must be willing to relocate to Anchorage, AK
